Article I

SCOPE

The price list for accommodation of STU employees in STU student dormitories in Bratislava (hereinafter referred to as "price list") is issued in accordance with Article V of the Rector's Directive No. 9/2014-SR Principles of accommodation for non-students in the accommodation facilities of the Slovak University of Technology in Bratislava as amended by Addendum No. 1 dated 31st May 2016 and Addendum No. 2 dated 26th June 2019.

The price list sets the prices for accommodation of STU employees in employment:

1. for accommodation spaces, set aside for employees in SD Akademik

2. for accommodation spaces, set aside for employees in SD Mladá Garda, Jura Hronca, Mladosť and Dobrovičova.

Article II

PRICES

Prices for accommodation are set per month. If the employee is not accommodated for the whole month, he/she pays an aliquot part.

b) If the accommodation capacity allows, other guests can also be accommodated in the accommodation spaces for a short time.

Article IV

FINAL PROVISIONS

1. Prices are listed without VAT.

2. If the accommodation is provided on the basis of an accommodation contract for a period longer than 3 months, it is exempt from VAT.

3. The price list becomes valid on the date of signature and takes effect on September 1, 2023.

4. On this day, the Price list File No. 02/2022 form 14th July 2022 for accommodation of STU employees in STU student dormitories in Bratislava becomes invalid.
