

# DECLARATION

OF UNDERGOING ENTRY-LEVEL INSTRUCTIONS FOR STUDENTS ACCOMMODATED IN THE STUDENT DORMITORIES OF ÚZ ŠDAJ STU IN OCCUPATIONAL HEALTH AND SAFETY (OHS), FIRE SAFETY (FS), AND CIVIL DEFENCE (CD)

## **Occupational Health and Safety:**

- 1) Housing rules for student dormitories and related internal instructions,
- 2) Operating rules of the student dormitories,
- 3) Act of the National Council of the Slovak Republic No. 124/2006 Coll., on Occupational Health and Safety, as amended,
- 4) Act of the National Council of the Slovak Republic No. 377/2004 Coll., as amended, on the Protection of Non-smokers, particularly Section 7, paragraph 1, letter d.

## **Fire safety:**

- 1) Act of the National Council of the Slovak Republic No. 314/2001 Coll., on Protection from Fire, as amended, particularly Section 14 on individuals' duties
- 2) Decree of the Ministry of Interior of the Slovak Republic No. 121/2002 Coll., on Fire Prevention, as amended, particularly Sections 12 and 31e,
- 3) Internal directive issued by the director of the student dormitories regarding inspection and the use of portable electronic appliances at the student dormitories,

## **Civil Defence:**

- 1) Act of the National Council of the Slovak Republic No. 42/1994 Coll., on the Civil Defence of the Population, as amended.

**I hereby declare** that I have been familiarised with the legislation and regulations specified above. I have been made aware of:

- the sources and potential causes of injuries and potential causes of fire,
- the ban on using personal electronic appliances (electric heating appliances are directly prohibited from use, including: hot plates, radiators, warm air heaters, electric convectors, pressure cookers, electric radiators, infra-red lamps, etc.)
- the ban on smoking throughout the student dormitories pursuant to Act No. 377/2004 Coll., on the Protection of Non-smokers, as amended.

## **I hereby pledge:**

- to abide by the housing rules of the student dormitories,
- to comply with OHS and FS regulations and measures,
- to ensure that my actions do not jeopardise the lives or health of others or my own life and health,
- to comply at all times with the basic rules of work safety and safe conduct and to make an effort to avoid injuries,
- to use only permitted and fully functioning electrical appliances and to follow the manufacturers' instructions for their use,
- to notify the director or technician of the student dormitories immediately if I discover a problem that could jeopardise safety and/or health,
- to refrain from smoking and working with open flames in the student dormitories,
- to refrain from leaving any electric or gas appliances switched on in the kitchen without direct supervision and to respect the ban on use of hot plates and electric radiators for heating rooms at the student dormitories,
- to refrain from using personal cookers for the preparation of meals in dormitory rooms,
- to keep my room, the kitchen, and the shared areas of the dormitories clean and tidy,
- to become familiar with emergency fire directives and the fire evacuation plan, which are located on signs in the corridors of the student dormitories, and in the event of a fire to follow the instructions specified in these directives and not to damage the signs,
- to refrain from damaging or misusing fire safety equipment, including portable fire extinguishers, hoses, hydrants, emergency lighting, and the public address system,

**UPON DISCOVERING A FIRE ON THE PREMISES, I WILL SWITCH OFF THE ELECTRIC POWER, ATTEMPT TO PUT OUT THE FIRE, AND IF IT CANNOT BE PUT OUT, WILL ANNOUNCE THE FIRE BY CALLING OUT "FIRE", PRESSING THE FIRE ALARM BUTTON, AND IMMEDIATELY REPORTING THE FIRE TO THE REPORTING STATION (RECEPTION).**
